Dear Colleagues,

I hope this finds you well and you enjoyed some R&R and a suitably socially distanced sojourn in the sun over the bank holiday weekend.

A week is a long time in politics and even more so during this crisis as behind the scenes activity moves at frenetic pace and take up masses of time whilst we simultaneously live life in a weirdly suspended state of animation.

SVS continues to maintain the SO:Linked website www.solinked.org.uk as the main source of information for the public and frontline staff on services and support available to help people during this time so please ensure your information is on there and kept up to date and let us know of any local resources that you come across that are available to add.

Two key areas we have been working on are volunteer brokerage and coordinating localised support to add capacity to SO:Linked's team of community navigators. This is based around the six "cluster areas" that the NHS and our Local Solutions Groups

have been working within (see map below).

These new Community Volunteer Coordinating Groups will assist in ensuring help is available for practical and emotional support such as shopping, pharmacy collections, and tackling social isolation at a local level, by working closely with voluntary sector and mutual aid organisations on the ground. Referrals will be directed through the SCC Covid-19 Helpline and SO:Linked Community Navigators.

For this initiative to be successful we are looking for additional help to form the core teams in each area. If you would like to get involved please email me personally j.ash@southamptonvs.org.uk and include Community Leadership Volunteer in the subject line. We aim to get these going next week so an immediate reply would be appreciated even if only as an expression of interest at this stage. If you have, or are, an underutilised staff member who can be redeployed to assist or with some funding could offer this as an alternative to furloughing staff we would be interested to hear from you as well as from experienced community organisers with DBS checks in place.


In terms of volunteering we are busy working on a Covid-19 volunteer brokerage system to sit within our Covid-19 directory, which is growing by the day. It is truly humbling to witness the amount of help the local sector, and self-organised mutual aid groups, are offering across the city. Our role is to offer support, guidance and coordination to ensure help gets to where it's needed safely and promptly.

Let us hope that when this too passes, as it surely will, that the kindness and generosity of volunteers and voluntary groups leaves us a legacy of stronger and more resilient communities than when we started facing this

together.

We should be considering our longer term sustainability and planning for recovery as well as for our immediate response so I hope the information in these special SVS mailings is helpful in keeping you informed and involved

YOUR COUNTY NEEDS YOU: GRANTS WILL SUPPORT CHARITABLE SECTOR IN FIGHT AGAINST COVID-19

Hampshire & Isle of Wight Community Foundation (HIWCF) is partnering with the NHS and Action Hampshire to provide a fund of £100,000 to enable the charitable sector to continue to play a vital role in supporting local communities affected by coronavirus.

Voluntary organisations or community groups requiring financial support to help them respond positively to the crisis can apply for a grant from the NHS Fund on the HIWCF website: https://www.hiwcf.com/grants/

HIWCF will be administering grants of between £1,000 to £10,000 for a wide range of support - for example, expenses for volunteers to carry out essential shopping or prescription collection trips for those at high risk of catching the virus, or supporting foodbanks to provide essential supplies and toiletry parcels for the most

vulnerable. Alternatively the funds could support voluntary organisations involved in transporting essential items such as parts to build ventilators, or befrienders providing a helpline and listening ear for those self-isolating without support.

Grants will be made available to organisations and groups providing innovative and resourceful services that will support the NHS in its battle against coronavirus, by perhaps providing drop-in centres to enable medical professionals to carry out testing, or groups that can supply suitably qualified staff to enable DBS checks to be carried out on volunteers.

Grant Cornwell MBE, Chief Executive at HIWCF

commented, "This vital funding from the NHS will support the smaller charities and community groups that are working incredibly hard to support local people whose lives have been impacted by coronavirus and we hope this will help some hospital beds to be freed up, and some people will be able to stay in their own homes. We are asking our network of community and charitable groups to help the NHS to make a difference, and if a small grant of £1,000 means they can keep volunteers out on the road helping vulnerable people in these unprecedented times, then this is the perfect funding for them."

Sue Dovey, Chief Executive at Action Hampshire said "It is critical at this time to enable local voluntary, community and social enterprise organisations to continue their vital work. This emergency fund will enable that to happen and Action Hampshire is delighted to support it."

Ros Hartley, Executive Director of Strategy and Transformation for the Hampshire and Isle of Wight Partnership of Clinical Commissioning Groups said: "NHS staff have received a huge amount of gratitude and appreciation recently, and we are deeply grateful for that. But we are also acutely aware that this is a team effort, and that we need to support each other. There are so many people and organisations out

there doing amazing and vital work - we wanted to make sure we were doing our bit to help them, just as they are helping our staff and the people who rely on them for care."

Chancellor Announces Lifeline For Charities

Chancellor, Rishi Sunak, has announced a £750m package designed to support struggling charities during the Coronavirus pandemic.

This follows concerns that some charities are facing huge financial challenges, with income streams such as charity shops, fundraising events and public donations being significantly impacted.

The support announced includes:

- £370m of funding that will support small, local charities working with vulnerable people. In England this support will be provided through organisations like the National Lottery Communities Fund. £60m of this will be allocated to Scotland, Wales and Northern Ireland.
- £360m (cash grants) available directly to charities who are providing
 essential services and supporting vulnerable people, as we battle
 COVID-19. £200m of this will go to supporting hospices. The rest will go
 to organisations like St John's Ambulance, Citizens Advice Bureau, as
 well as charities supporting vulnerable children, victims of domestic
 abuse or disabled people.
- The Government will match pound for pound whatever the public donates to the BBC 'Big Night In' charity appeal on 23rd April, starting with at least £20m to the National Emergencies Trust appeal.

This is welcome news for the charity sector, which we hope will ease the financial strain on lots of charities and support other measures such as the

Coronavirus Job Retention Scheme (CJRS).

As with all of the financial measures the Government has been announcing it will take a little while for the details around eligibility and applying to be made available, we will keep you updated.

A useful round-up of Covid-19 funding opportunities from our friends at Action Hampshire

Crisis - Emergency Grant

Crisis has established an emergency grants fund for organisations that have expanded their provision to meet the current needs of people experiencing homelessness. Grants of up to £5,000 for short-term responses; and up to £50,000 to fund long-term needs and potential expansion or change in service delivery. Apply here

Elton John Aids Foundation - Covid Emergency Fund

The Elton John AIDS Foundation is accepting applications from local community-based organisations. Proposals must address specific challenges in relation to COVID-19 for people already living with or at severe risk of HIV/AIDS.

Fashion and Textile Children's Trust – Grants for families financially affected by Coronavirus

Grants are available to help parents and carers who have worked in the UK fashion or textile industry and whose household income has reduced as a result of the coronavirus outbreak.

Barclays Foundation – Coronavirus Fund

The Barclays Foundation will be giving out £100 million - half of in the form of direct funding for charities, while the other half is a commitment to match employees' donations, including senior figures in the corporate pledging a third of their salary. We don't yet know how the funding can be accessed, but will keep you posted Apply here

The National Lottery Heritage Fund - Emergency Fund

£50million fund to support the heritage sector as an immediate response to the coronavirus (COVID-19) outbreak. Grants of between £3,000 and £50,000 are available to organisations which have received funding in the past or are a current grantee.

The Prince's Trust and NatWest Enterprise Relief Fund

The Prince's Trust and NatWest have launched a £5million grant fund for young entrepreneurs affected by coronavirus. The Fund is available to entrepreneurs aged 18-30, who can apply for grants and tailored support.

Standard Life Foundation - Coronavirus pandemic – fast track applications

Funding is available for work directly related to the pandemic, addressing specific challenges and helping to contribute to social change which tackles financial problems and improves living standards for those on low-to-middle incomes in the UK. Grants from £5,000 upwards are available.

Food redistribution - Resource Action Fund

Defra are making £3.25m available through the Resource Action Fund administered by WRAP. The fund will be delivered in three phases. Phase 1: WRAP will contact a target list of small redistribution organisations who have previously applied for funding. Phases 2 and 3 will be launched shortly. Check the website on Thursday 9th April.

Tesco Bags of Help - Covid-19 Communities Fund

Tesco Bags of Help is setting up a new short-term fund. Organisations supporting vulnerable groups are encouraged to apply for a grant of £500 to support organisational need in this time of crisis rather than fund specific projects.

Virgin Money Foundation

have announced that they will make £500,000 available for existing grantees through their Community Resilience Fund. An additional £252,731 will be available through the pre-existing Community Anchors Fund, which supports locally-led organisations making a positive difference to their neighbourhoods, to help groups affected by the virus.

ITF Seafarers Trust – Covid-19 Welfare Fund

An extraordinary fund established for a limited period to provide grants to benefit seafarers and maintain seafarers' welfare services in difficulties due to the Covid-19 pandemic and its financial consequences.

Innovate UK

Innovate UK, as part of UK Research and Innovation, will fund projects up to a maximum of £50,000. Your application must demonstrate both realistic and

significant benefits for society (including communities, families and individuals) or an industry that has been severely impacted and/or permanently disrupted by the Covid-19 pandemic. Closing date 17th April.

Neighbourly micro-grants

Neighbourly is offering a series of microgrants up to £400 to existing members in the UK and Ireland.
